## Service of Coverage

The parties agreed that Utopia Video Productions will furnished professional Videography services and event coverage beginning at **TBA** until **TBA**. For coverage of 6 hours or more, the client will provide the videographer and his assistant (if applicable) with a hot meal.

## Payment Policy and Expenses


A fee of **\$2,000** is not refundable, but may be re-applied (subject to availability) if the event is reschedule. Any photos, music or material to be used in the video, must be received by Utopia Video Productions at least two weeks prior to the event, and no later than two weeks after in order to be included. Utopia Video Productions is not responsible for any unforeseen changes in schedule or rules applicable to the site in terms of lighting, sound, audio interference or camera placement. Utopia Video Productions promises a final product to and according to the actual event audio-visual quality and guests' participation. A final cut will be delivered including all of the material at the editors best judgment according to the standards of Utopia video productions philosophy, any changes will incur additional editing charges. Thirty (30) days after delivery confirmation, all files must be deleted. ~~Raw footage is not available under any circumstances.~~ The presence of Utopia Video Productions must be the only professional video service rendered that day; the presence of another videographer will automatically terminate this agreement. Utopia Video Productions is not responsible for any photographer flash or light interference affecting the final product quality.

I consent that the videographer, his legal representative, successors or assigns, shall have the absolute right and permission to copyright, publish, use or assign any video clips taken on this or any subsequent dates, whether apart from or in conjunction with my own fictitious name, or thereof. Guest should be advised that video taken at the event is subject to use in aforementioned uses.
